## ENTRIES

### PRE-ENTRY ONLY.

**\$23** per dog. **\$15** second entry of the same dog, same trial

**\$15** per entry for Junior Handlers

**\$15** per dog for Non-Licensed obedience classes (offered Trial 1 only)

*(\$25 fee to be charged on all returned checks)*

Deadline for entries - **6:00 p.m. May 10, 2017** or when entries fill (55 entry limit for Obedience, and 125 entries for Rally Obedience.) After this time entries cannot be accepted, canceled or substituted. No refunds after entries close. **A waitlist will be established** (please review waitlist rules on the UKC website.)

No female in season may participate in an obedience trial. Bitches in season are not permitted to compete in Rally, Obedience or Agility. A refund of 50% of the entry will be returned if the exhibitor provides a veterinarian's certificate verifying that the female came into season after the closing date for entries. The certificate must be delivered to the Trial Secretary before the published start time of the trial.

Exhibitors are responsible for entering the correct classes. Please read the entry form for instructions. Incomplete forms will be returned. Returned checks do not constitute a valid entry. Cash payment ONLY of the face amount of a returned check plus a collection fee of \$25 will be required before the entrant is allowed to compete. **NO PERSONAL CHECKS DAY OF SHOW WILL BE ACCEPTED.**

### JUDGING

Judging will begin at 8:00 a.m. both days

### Order of Judging

**Saturday May 20, 2017 (Rally Obedience) – Trial 1:** URO3 (B & A), URO2 (B & A), URO1 (B & A). **Trial 2 to follow.**

**Rent-A-Ring:** To follow Trial 2.

**Sunday May 21, 2017 (Obedience) – Trial 1:** Utility B & A, Open B & A, Novice B, A, & C. Followed by Grad Open, Grad Novice, Sub Novice, and Team. **Trial 2 to follow:** Utility B & A, Open B & A, Novice B, A, & C.

Exhibitors must check in 1/2 hour before judging starts for your class. "Move ups" to be approved 1/2 hour before the start of the trial. **Electronic timers may be used for Rally Obedience.**

TPDC is not responsible for items lost or left at the show site. If, because of riots, civil disturbances, weather, or other act beyond the control of the management, it is impossible to open or complete this show, NO refund of entry fees will be made. NO substitutions are allowed.

Only UKC registered dogs may be entered in these trials. Mixed breed dogs which have a UKC LP (limited privilege) registration may enter and are welcome. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of UKC rules and regulations and agree to abide to all rules in affect at the time of this trial. **FROM THE NORTH** - Take I-25 to Colorado 66 (exit 243). West on 66 to Hover Road (approx 8 miles). South on Hover to Nelson Road (approx 3 1/2 miles). East on Nelson Road and left into fairgrounds.

**FROM THE SOUTH** - I-25 to Colorado 52 (exit 235). West on 52, also marked Mineral Rd. (approx 8 miles) to 95th street (3rd stop light). North on 95th Street (Hover Road) to Nelson Road (approx 5 miles). East on Nelson Road and left into fairgrounds.
