## Running order

Friday - AGI -trials 1 & 2, AGIII -trials 1 & 2, AGII -trials 1 & 2  
Saturday - AGII -trials 1 & 2, AGIII -trials 1 & 2, AGI trials 1 & 2.

Only UKC registered dogs may be entered in these trials. Mixed breed dogs which have a UKC LP registration may enter and are welcome. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of UKC rules and regulations and agree to abide to all rules in affect at the time of this trial. A copy of the current rules can be obtained by calling UKC (269) 343-9020 or visiting their web site at [www.ukcdogs.com](http://www.ukcdogs.com).

Please note that AGI and AGII classes are divided into A and B. The A class is for those dogs that have not yet earned their UAGI or UAGII titles. The B class is for those dogs that have earned the above mentioned titles, and are working on their UACH or UGRACH title. Individual familiarization runs before each size division for AGI -A and AGII -A classes only. These runs will be done on lead and only one attempt at each obstacle will be permitted. Short leads are preferred for familiarization runs.

**Exhibitors must check** in 1/2 hour before judging starts for your class. "Move ups" must be submitted within a 1/2 hour of conclusion of judging on Friday. No same day move-ups.

DIV TOY= 4 inch; shoulder height up to & including 10".  
DIV 1 = 8 inch; shoulder height over 10" up to & including 14".  
DIV 2 = 14 inch; shoulder height over 14" up to & including 20".  
DIV 3 = 20 inch; shoulder height over 20".

**CALCULATING ENTRY FEES.** The below are calculations PER DOG.

The weekend of July 14 & 15 has four separate trials offered. There are two trials on Friday that each offer AGI, AGII, and AGIII. There are two trials on Saturday offering the same three classes. The discounted run applies to additional entries of the same trial. For example:

Entering one class (ie AGI): 1 trial \$23, 2 trials \$46, 3 trials \$69, 4 trials \$92  
Entering two classes (ie AGI & AG2): 1 trial \$33, 2 trials \$66, 3 trials \$99, 4 trials \$132  
Entering all three classes: 1 trial \$38, 2 trials \$76, 3 trials \$114, 4 trials \$152
